Applicant understands that if accepted, he/she will pay an initial one-time set-up fee of \$399.00 cash and \$99.00 trade dollars. Thereafter, applicant agrees to pay a cash transaction fee of 6.5% on all barter purchases and 6.5% on all barter sales when providing a valid credit card (a cash transaction fee of 8% on purchases and sales will be charged when a valid credit card is not provided or is unable to process), a monthly account maintenance fee of \$15.00 cash and \$15.00 trade and a cash administrative fee of \$199.00 billed annually upon the client's anniversary date.

MEMBER FEES:

Applicant (once approved as a Member) agrees to pay (i) a cash transaction fee of 6.5% on all barter purchases and 6.5% on all barter sales when providing a valid credit card (a cash transaction fee of 8% on purchases and sales will be charged when a valid credit card is not provided or is unable to process), (ii) a monthly account maintenance fee of \$15.00 cash and \$15.00 trade and (iii) a cash administrative fee of \$199.00 billed annually upon the anniversary date of the Applicant's acceptance as a Member.
